Beth Dutton recently came onboard as the Senior Group Manager, Stormwater at the Pittsburgh Water and Sewer Authority, where she is leading PWSA's newest engineering department. The Stormwater Group plans, designs, monitors, and maintains stormwater-related projects to help reduce local flooding and combined sewer overflows and improve the water quality and health of streams and waterways.

She has collaborated with many Pittsburgh-area stormwater professionals over the years in her positions at engineering consulting firms and at the environmental non-profit 3 Rivers Wet Weather.
